A 1. Approve the Provisional Internship Permit request for a certificated employee Martiesia Canes, Orlando Magana, and Diondra Eubanks. In order to exercise additional options in which to fill a vacant certificated position, JLPAA will be submitting Provisional Internship Permit request application to the Commission on Teacher Credentialing for approval. Pursuant to State mandate, the Governing Board must approve Provisional Internship Permit requests allowing the

district to employ and assign teacher(s) who do not hold appropriate credential authorization. The Provisional Internship Permit will allow the District to place an individual who has not yet met the subject matter competence requirement needed to enter an internship program. The permit is for 2024-2025.

Staff Recommendation: Approval of Provisional Internship Permit for Martiesa Canes, Orlando Magana, and Diondra Eubanks, 2024/2025.

A 2. Approval of the J-13A Form. The California Department of Education's (CDE) Form J-13A is used by local educational agencies (LEAs) to request approval for attendance and instructional time credit when a school is closed, or attendance is reduced due to an emergency. JLPAA was closed on September 10, 2024, through September 13, 2024, due to the Airport Fire.
